

**SINGLE NET STRAW - SNS 1**

GreenSolutions™ Erosion Control Blankets consist of 100% agricultural straw mechanically bound and covered on one side by netting. The straw is homogeneously blended and evenly distributed throughout the blanket. The netting is photodegradable polypropylene with mesh openings of approximately 3/8 in. by 3/8 in. The blanket is sewn on approximately 2 in. centers with photodegradable polypropylene thread.
